MEMORANDUM OF UNDERSTANDING ON ACADEMIC AND RESEARCH COOPERATION BETWEEN

CHIANG MAI UNIVERSITY FACULTY OF MEDICINE, THAILAND

AND

SEOUL NATIONAL UNIVERSITY COLLEGE OF MEDICINE, REPUBLIC OF KOREA

The Chiang Mai University Faculty of Medicine, Thailand hereinafter referred to as CMUFM and Seoul National University College of Medicine, Republic of Korea, hereinafter referred to as SNUCM, considering their common interest in promoting mutual cooperation in the areas of education and research, both parties, therefore, wish to expand their friendship into cooperative educational exchanges, and have set forth the following Memorandum of Understanding (MOU):

Article I: Purpose

The purpose of this MOU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote relations and mutual understanding between both universities.

Article II: Scope of the Cooperation

Both parties undertake to promote and develop academic cooperation as follows:

- 1. Exchange of academic and administrative staff and students.
- 2. Cooperation in research and the presentation of its results.
- 3. Exchange of academic materials, publications and other scientific information.
- 4. Collaboration and exchange of resources and staff in the area of library and other auxiliary services.
- 5. Other educational and academic exchanges to which both universities agree.

Article III: Financial Arrangement

- 1. Both parties agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds.
- 2. Both parties agree to seek financial support from national and international organizations for the cooperative activities to be undertaken as stated under the terms of this MOU.

Article IV: Agreement of Implementation

A detailed description of the scope of activities shall be defined in the Agreement of Implementation, which is negotiated between the two parties as each specific case may arise.

The Agreement of Implementation will include such items as:

- 1. Detail Descriptions of the responsibilities of each institution for the agreed upon activity.
- 2. Schedules for specific activities.
- 3. Budgets and sources of financing for each activity.

4. Any other items deemed necessary for the efficient management of the activity.

Article V: Intellectual Property Rights and Publication

- 1. The parties will share all data and research findings, patent rights, copyrights, and other intellectual property rights to any discoveries, inventions and products resulting from this MOU.
- 2. Both parties must give written approval for the utilization and publication of the shared data and research findings.
- 3. Detailed management of the Intellectual Property Rights and Publications shall be defined in the Agreement of Implementation of each activity.

Article VI: Settlement of Differences

The differing viewpoints and interpretations of this MOU shall be settled amicably by mutual consultation or negotiation.

Article VII: Amendments, Duration and Termination

- 1. Amendments to this MOU can only be made by mutual written consent.
- 2. This MOU shall be in effect from the date of its signing and be valid for the duration of five (5) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new MOU.
- 3. This MOU may be terminated by either party with a least six (6) months prior written notice. Such notice of termination will not interfere with cooperative programs currently underway and such programs will be allowed to continue until their conclusion.

This MOU is prepared in English and two (2) original copies of this MOU are produced. Both copies are authentic. As witness to their consent this MOU, the appropriate authorities hereunto provide their signatures:

STUDENT EXCHANGE AGREEMENT BETWEEN CHIANG MAI UNIVERSITY FACULTY OF MEDICINE, THAILAND

AND SEOUL NATIONAL UNIVERSITY COLLEGE OF MEDICINE, REPUBLIC OF KOREA

The Chiang Mai University Faculty of Medicine, Thailand and Seoul National University College of Medicine, Republic of Korea, wishing to strengthen their academic relations and productive cooperation between the faculties in their respective universities, agree as follows:

Article I: Purpose

The purpose of this agreement is to initiate a student exchange agreement between the Chiang Mai University Faculty of Medicine and Seoul National University College of Medicine.

Article II: Scope of the Cooperation

Both parties agree to participate in a reciprocal student exchange agreement, whereby each university agrees to accept a maximum of (2) student(s) from the other per year. The duration of the exchange study period is up to (1) semester for one (1) academic year. While student numbers may vary each year, every effort will be made to keep the exchange in balance each year and the number of students accepted on a given year may be adjusted to achieve parity.

Article III: Financial and Academic

- 3.1 Each host university will exempt tuition fees for incoming exchange students.
- 3.2 Both parties will recognize academic credits earned by students participating in this program.

Article IV: Administration

4.1 Each university will designate a Liaison Officer to develop and coordinate specific

- activities for the student exchange program
- 4.2 Each university will make every reasonable effort to give priority for on-campus housing to students participating in this student exchange program.
- 4.3 Candidates will be recommended by the home university generally on the basis of academic merit and shall be subjected to final approval by the host university.

Article V: Duration

This agreement shall be effective from the date of signature for a period of five (5) years with the understanding that it may be terminated by either party by giving six months' prior written notice to the other party. Such notice of termination will not interfere with cooperative programs currently underway and these programs will be allowed to continue until their conclusion.

This agreement may also be extended or amended by mutual written consent.
